## 1. INTRODUCTION

In line with Article 27 of Council Regulation (EC) No 732/2008 (hereinafter, "the Basic Regulation"), this report provides statistical information on the salient aspects of the GSP scheme (2006-2009). Reference is also made to the Impact Assessment accompanying the Commission's proposal for a new GSP Regulation, which contains a broader set of data and information on the GSP scheme and its effects. It is possible that some minor variations may be found between the figures in this report and those of the Impact Assessment. This may be due, for example, to different dates of retrieval of the information from the relevant databases, in which the data are refined and/or updated regularly. The following terminology has been used in this report:

Covered Imports: Imports of products listed in the GSP regulation, (including those imports for which a country is graduated out of any section / does not benefit from preferences for a given product section).

Eligible imports: Imports of products for which the country of origin is entitled to GSP treatment.

Preferential imports: Products placed under the customs procedure of free circulation under GSP preferences.

Utilisation rate: The ratio of preferential imports to eligible imports. It indicates the imports which actually benefit from tariff preferences as a share of the total amount of imports for which such preferences are available.

"Loss" of income: The nominal loss of EU customs revenue due to the application of preferences, assuming that trade remains the same in a situation without preferences.

Preferential margin: This is the difference between the tariffs paid by countries that do not benefit from preferential access to EU markets (MFN) and those that do benefit from the preference scheme, expressed in percentage points. Example: A tariff preference of 30% from an MFN duty of 10% gives a preferential margin of 3 percentage points and a preferential tariff of 7%.

All statistics have been obtained from COMEXT.

For lists of countries falling under each arrangement, please see the Basic Regulation. Given that Sri Lanka was temporarily withdrawn from GSP+ after 2009, its data are included under the GSP+ category. Given that Venezuela moved from GSP+ to GSP after 2009, its data are included under the GSP+ category. Cape Verde was withdrawn from EBA in 2007 but remains under the EBA category during the period, as it benefits from the transitional period established in Article 11(8) of the Basic Regulation. Given that Maldives was withdrawn after 2009, its data are included under the EBA category.

## 2. EVOLUTION OF PREFERENTIAL IMPORTS

### 2.1. General overview

The following tables provide a general overview of imports from beneficiary countries in 2006 and in 2009. (For certain countries – mainly small island territories – Eurostat does not report data for total world exports.)

The 40 tariff lines that are dutiable corresponded to products under tariff headings 1006 (rice) and 1701 (sugar) which were totally liberalised in September and October 2009 respectively. Arms and ammunition (22 industrial tariff lines) are excluded from the arrangement.
