The Council took note of the Presidency's Progress report as set out in doc. 17019/11.

The Commission expressed strong reservations on the latest Presidency compromise text as set out in doc. 16722/11 REV 1, in particular with regard to the issues of derogations and of exposure limitations and methodology. The Commission also hoped that the co-legislators would be able to finalise their work before 30 April 2011, the legal deadline for transposing the Directive 2004/40/EC in force.

DE and UK invited the Commission to present a proposal regarding the extension of the transposition deadline beyond 30 April in order to allow for more in-depth discussions, DE specifically mentioning a period of 2 years.

IT supported the efforts deployed by the Polish Presidency and hoped that the Danish Presidency would use the Presidency compromise proposal as a basis for further work on this dossier.

While a large number of delegations was in favour of extending the crisis derogation, several of them considered that the derogation did not fulfil its objective and that this issue should remain under national competence.

As the required majority for the prolongation of the crisis derogation was not attained, no political agreement could be reached on this file.

In this context, the Council agreed to enter a minutes statement by BE, CY FR, EL, IE, IT, PT, RO and ES as set out in annex II.
