Commission Statement

"The Commission welcomes the first reading agreement between the European Parliament and the Council on Regulation (EU) No 19/2013 implementing the bilateral safeguard clause and the stabilisation mechanism for bananas of the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part.

As envisaged in Regulation (EU) No 19/2013, the Commission will submit an annual report to the European Parliament and to the Council on the implementation of the Agreement and will be ready to discuss with the responsible committee of the European Parliament any issues arising from the implementation of the Agreement.

The Commission will attach particular importance to the effective implementation of commitments on trade and sustainable development in the Agreement, taking into account the specific information provided by the relevant monitoring bodies of the fundamental Conventions of the International Labour Organisation and the multilateral environmental agreements listed in Title IX of the Agreement. In this context, the Commission will also seek the views of the relevant civil society advisory groups.

After the expiry of the stabilisation mechanism for bananas on 31 December 2019, the Commission will assess the situation of the Union market for bananas and the state of Union banana producers. The Commission will report its findings to the European Parliament and to the Council and will include a preliminary assessment of the functioning of the "Programme d'Options Spécifiques à l'Éloignement et l'Insularité" (POSEI) in preserving the banana production in the Union."

Joint Declaration

"The European Parliament and the Commission agree on the importance of close cooperation in monitoring the implementation of the Agreement and Regulation (EU) 19/2013 implementing the bilateral safeguard clause and the stabilisation mechanism for bananas of the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part ¹. To that end they agree on the following:

- Upon request by the responsible committee of the European Parliament, the Commission shall report to it on any specific concerns relating to the implementation by Colombia or Peru of their commitments on trade and sustainable development.
- If the European Parliament adopts a recommendation to initiate a safeguard investigation, the Commission will carefully examine whether the conditions under Regulation (EU) No 19/2013 for ex-officio initiation are fulfilled. If the Commission considers that the conditions are not fulfilled, it will present a report to the responsible committee of the European Parliament including an explanation of all the factors relevant to the initiation of such an investigation."

Ad deep-sea sharks

"The Commission will examine the list of species defined as deep-sea sharks in part 1 ("Definition of species and species groups") of the Annex to the Regulation, in particular as regards the possible exclusion of Blackmouth catshark (*Galeus melastomus*) and the possible inclusion of Lowfin gulper shark (*Centrophorus lusitanicus*). Where appropriate, the Commission may propose to amend this list, in the light of scientific advice it may receive on this matter."

Ad red seabream in area IX

"The Commission notes that a rollover of the 2012 TAC for Red seabream in area IX has been agreed, acknowledging national efforts being made for the sustainable management of the stock. The Commission shall request scientific evaluation of relevant national measures for the protection of the stock."

Statement by Sweden

"Sweden believes in the importance to apply the principles enshrined in the UN Agreement on Migratory Stocks and in the International Guidelines for Deep Sea Fishing from 2008, particularly concerning the stock assessments, impact assessments and the application of the precautionary approach. Where no scientific advice is available the precautionary approach should apply. On 29 of November the Council reached a political agreement on the proposal for deep sea species for 2013 and 2014. Sweden will vote no to the final compromise because the precautionary approach has not been applied for stocks where no reliable scientific advice is available."

- the legal form of the legislative instrument, in respect of which Italy confirms its preference for an instrument that is directly applicable in the Member States, such as a Regulation, which is more effective for such a sensitive issue as safety;
- the scope of the Regulation, regarding which Italy confirms its preference for including the vehicle categories L (motorcycles) and O2 (trailers)."
