<u>The Council</u> approved the amendment set out in the European Parliament's position at first reading and adopted the proposed act amended accordingly, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. (Legal basis: Article 118 of the TFEU).

<u>Statement by the participating Member States</u> on the share of distribution of renewal fees for european patents with unitary effect

"The participating Member States look forward with confidence to the decisions by the Select Committee, to be set up within the Administrative Council of the European Patent Office, concerning the level of the renewal fees for European patents with unitary effect and the share of distribution of such fees among the participating Member States.

When deciding on the share of distribution of the renewal fees, the representatives of the participating Member States will be guided by the criteria listed in Article 13(2) of the Regulation implementing enhanced cooperation in the area of the creation of unitary patent protection, with the aim of allowing all participating Member States to keep their current renewal fee income while at the same time ensuring that those Member States which currently have a low renewal fee income will significantly increase this income."
