There had also been a preliminary exchange of views on governance issues.

The Commission stressed that it would be important to avoid excessive administrative burden for the Programme and promised its support to the negotiations.

The Council held an exchange of views (doc. 16095/12) on the Europe 2020 governance and follow-up of the European Council conclusions in the field of employment and social policy.

The Council agreed with maintaining last year's AGS priorities, whilst a more in-depth analysis remained to be carried out. Delegations stressed that emphasis needs to be put on the implementation of the recommendations. Some delegations noted that the AGS has on certain specific issues a lower social focus (no longer recognises the role of social protection as an automatic stabiliser; presents the pension systems only under their financial sustainability; social protection systems reduced to safety net for the poorest).

Against this first analysis, Ministers expressed that EPSCO should send a message to the European Council to maintain social objectives as part of a future closer economic integration (*social pillar for the EMU*) - the main results of the EPSCO discussion on 6 December 2012 are summarised in a letter dated 10 December 2012 from the EPSCO Chair (Cypriot Minister of Labour) addressed to the GAC / European Council.

### **Statement by Malta**

"Malta believes that Member States should always be compared with their starting positions, and that their respective national circumstances should be taken into consideration given that the dynamics of their economies are very different.

For this reason, Malta considers that comparisons drawn with the 5 best performers is counter-productive, and that any benchmarking exercise should be conducted within parameters as delineated by the respective national targets.

Moreover, if one opts to benchmark Member States against each other, then Malta feels that this should be done against the EU 2020 targets and not the best five performers.

In view of the above, Malta would like to clarify certain figures for Malta in relation to employment for women and older workers and highlight that the main difficulties that it faces in this regard pertain to attracting into the labour market older women who have never worked before. Although Malta continues to actively encourage female participation in the labour market, it must be recognised that there are considerable difficulties in attracting older women who have never worked in the past, in particular owing to the cultural and historic traditions related to the participation of women in the labour market.

Furthermore, with regard to Malta's Early School Leaving (ESL) rate, as has already been done in recent publications by the European Commission including the Education and Training Monitor 2012, it should be acknowledged that the Maltese series on ESL are under review by the Maltese National Statistics Office and Eurostat. The review concerns the classification of certain qualifications at secondary level and applies to all years covered (2006-2011) and would mean a reduction of about 9 percentage points for the 2011 rate of early school leavers."

## **Statement by France**

### **Can Europe do without 20% of its growth?**

#### **French proposals to refocus European economic governance on the activity of women**

"The Organisation for Economic Co-operation and Development (OECD) estimates that a quarter of the economic growth recorded in European Union countries since 1995 has come from women's increased participation in the labour market. A study presented to the Ministers of Equality of the 27 Member States, during a meeting organized in Stockholm in October 2009, showed that the output gap linked to gender inequalities in the EU was in a bracket between 15% and 45% of gross domestic product (GDP), figures that go far beyond all technological progress.

Only 62.1% of women currently participate in the European job market – 13 percentage points below men. This is a massive loss of wealth, just as women today leave the educational system with a higher level of studies than men do. The countries that have employment rates greater than or equal to 70% (Sweden, Denmark, the Netherlands) are all in the leading group in terms of per capita wealth.

For the European economy to follow in the footsteps of these countries, we feel that two evolutions in particular should be prioritized.

#### **➤ Set objectives to mobilize the tools of the new economic governance**

France proposes to its partners and to the European Commission the components of an “equality” pillar of the EU’s new economic governance, built around four indicators:

1. the employment rate gap between men and women
2. pay gaps
3. inequality between men and women in terms of retirement
4. compliance with the Barcelona Goals.<sup>1</sup>

Monitoring of these indicators should be the subject of an annex to the report on the Annual Growth Survey.

On this basis, we wish that the European Commission would consider with strict attention the reach of these objectives in its recommendations to Member States, in the framework of Country-specific Recommendations.

Dialogue with the European social partners could take place in the framework of European tripartite dialogue, planned in the framework of the European semester. Generally speaking, the role of social partners in the framework of the report on the Annual Growth Survey could be strengthened.

<sup>1</sup> These goals were adopted during the European Council in Barcelona in March 2002, which called on the Member States to “*remove disincentives to female labour force participation and strive, taking into account the demand for childcare facilities and in line with national patterns of provision, to provide childcare by 2010 to at least 90% of children between 3 years old and the mandatory school age and at least 33% of children under 3 years of age*”.

➤ **Use European Union competencies in support of a renewed conception of pay equality**

Under the recast directive 2006/54 on the implementation of the principle of equal opportunities and equal treatment of men and women in matters of employment and occupation, a difference in pay between men and women can only be justified by the nature of the occupational activities concerned and if the measures taken are legitimate and proportionate.

In order to follow up the application of this text, the European Commission could be asked to elaborate with the specialized agencies the definition of a European tool to assess compared situations making it possible to assess pay gaps in business and determine their causes."
