At the request of the Chair, the Council Legal Service intervened to explain the legal difficulties that arose from the proposed one-stop-shop mechanism from the point of view of the right to an effective remedy. The Commission disagreed with the reasoning of the CLS.

Following a lengthy debate, it was clear that there was no majority behind the proposal for giving some exclusive powers of corrective measures to the data protection authority of the main establishment. The Chair therefore concluded that there were diverging opinions between Member States and work needed to be continued at technical level, including by looking at cooperation between supervisory authorities and at the possibility of entrusting the European Data Board with legally binding powers.
