LEGISLATIVE DELIBERATIONS

1. Regulation of the European Parliament and of the Council amending Regulation (EU) No 443/2009 to define the modalities for reaching the 2020 target to reduce CO2 emissions from new passenger cars [First reading] (LA+S)

<u>The Council</u> approved the amendment set out in the European Parliament's position at first reading and adopted the proposed act amended accordingly, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. (Legal basis: Article 192(1) of the TFEU).

Commission Statements:

On 2025 target

"In carrying out its impact assessment of a 2025 target the Commission will consider the appropriateness of a range of ambition levels/rates of reduction, coherent with the long term climate goals of the EU and the emission reduction trajectory referred to in recital 7 of Regulation (EU) No. xxx/2013. This assessment will cover the range of ambition sought by the European Parliament for a 2025 target in the range of 68g to 78g CO₂/km, equivalent to 4-6% reduction per year in relation to the 2020 target. The impact assessment will also need to consider a wide range of issues among which will be long term climate policy goals, cost-effectiveness, competitiveness, technology availability, social equity, neutrality with respect to competition. Any conclusion reached in the impact assessment on the appropriate level of ambition for a 2025 target would need to balance effects in the range of different areas assessed.

On WLTP

"The Commission strongly supports the ongoing work in the framework of the UNECE, with the aim of a target date for the WLTP to be operational for new vehicle types by 1 January 2017. The work at UNECE is well underway and subsequently the Commission would aim to implement the new test cycle and test procedures into EU law in 2014."

On the procedure of adoption of implementing acts

"The Commission underlines that it is contrary to the letter and to the spirit of Regulation 182/2011 (OJ L 55 of 28.2.2011, p. 13) to invoke Article 5(4), subparagraph 2(b) in a systematic manner. Recourse to this provision must respond to a specific need to depart from the rule of principle which is that the Commission may adopt a draft implementing act when no opinion is delivered. Given that it is an exception to the general rule established by Article 5(4) recourse to subparagraph 2(b), cannot be simply seen as a "discretionary power" of the Legislator, but must be interpreted in a restrictive manner and thus must be justified."

Joint statement by Belgium, Denmark and the Netherlands

"As it is of the utmost importance to provide car manufacturers with predictability, Belgium, Denmark and the Netherlands support the adoption of the "Regulation of the European Parliament and of the Council amending Regulation (EC) No 443/2009 to define the modalities for reaching the 2020 target to reduce CO2 emissions from new passenger cars" while calling for an adaptation in due time of the level of ambition in line with the "Roadmap for moving to a competitive low carbon economy in 2050" (COM (/2011) 0112 final) and for the implementation as soon as possible of a revised test cycle and related test procedures in order to better reflect real life vehicle emissions."

2. Regulation of the European Parliament and of the Council on the Fund for European Aid to the Most Deprived [First reading] (LA+S)

<u>The Council</u> approved the amendment set out in the European Parliament's position at first reading and adopted the proposed act amended accordingly, with <u>the Danish and the United Kingdom delegations</u> voting against, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. (Legal basis: Article 175(3) of the TFEU).

Statement by the United Kingdom

"The UK believes that the Fund for European Aid to the Most Deprived is not consistent with the principle of subsidiarity. Food and material aid measures are better and more efficiently delivered by individual Member States through their own social programmes and their regional and local authorities. EU-financed action on social inclusion should be delivered through the European Social Fund rather than by creating a separate Fund."

Statement by Denmark

"Denmark recognises the need for special actions targeted the most deprived people in Europe.

However, Denmark finds that material assistance as proposed in the Fund for Aid for the Most Deprived lies within the competence and the responsibility of the Member States and therefore Denmark has been opposed to the Fund from the outset.

Based on this, Denmark maintains its overall reservation towards the Fund."

<u>The Council</u> approved the amendment set out in the European Parliament's position at first reading and adopted the proposed act amended accordingly, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. (Legal basis: Article 114 of the TFEU).

Statement by Germany

- "1. Regarding the second bullet point under "The Council of the European Union stresses that", on page 3: In accordance with the conclusions of the European Council, the use of a broader range of indicators from the scoreboard of social indicators aims at achieving a broader understanding of social developments. The scoreboard and its indicators must be developed further on an ongoing basis.
- 2. Regarding the fourth bullet point of page 8: EMCO's mandate is set out in Article 150 TFEU. EMCO has no mandate for action in the context of monitoring economic policies under Article 121. The arrangements provided for in the macroeconomic imbalance procedure must be fully complied with.
- 3. At the European Council meeting in December 2013 it was agreed that the European Council would decide on the next steps to strengthen coordination of economic policies through contractual arrangements at its meeting in October 2014. This process should not be prejudged."
