#### 5. Ensuring a teaching profession of the highest quality to underpin the achievement of better learning outcomes

Policy debate 8573/13 EDUC 110 SOC 251

The Council held a policy debate on the basis of the question paper prepared by the Presidency (see doc. 8573/13), in the presence of two external guest speakers:

- Ms Christine Blower (President ETUCE and General Secretary of the UK's National Union of Teachers:
- Mr Pasi Sahlberg (Director General of Finland's Centre for International Mobility and Cooperation.

At the conclusion of the debate the Chair highlighted the critically important role that teachers play in enhancing young people's employment prospects, as well as their life chances in general. Outlining some of the main factors influencing the quality and effectiveness of the teaching professions, the Chair stressed the importance of attracting, recruiting - and retaining - the most talented people, of improving their initial preparation, of providing them with the right mix of skills and knowledge throughout their careers, and of ensuring that they receive regular feedback, appraisal and support.

#### 8. Europe's young people: what can quality youth work contribute to addressing current challenges?

The Council held a policy debate on the basis of the question paper prepared by the Presidency (see doc. 8578/13) in the presence of two external speakers:

- Dr Massimiliano MASCHERINI, Head of Research, Eurofound, Dublin, Ireland;
- Dr John BAMBER, Centre for Effective Services, Dublin, Ireland.

At the conclusion of the debate, the Chair stressed that an investment in youth is for the long term but the returns go beyond the economic dimension. Engagement of young people through youth work can be an important step towards participation in more formal education and training programmes and employment. In this regard recognition and validation of nonformal and informal learning were highlighted.

## 12. Use of culture as a soft policy option in EU external relations

Policy debate
 8235/13 CULT 31 AUDIO 43 RELEX 275

The Council held a policy debate on the basis of the discussion paper prepared by the Presidency (see doc. 8235/13). At the conclusion of the debate, the Chair noted that ministers generally agreed that the principles and recommendations outlined in the EU-China expert group's report seemed a good basis for developing a strategic approach to culture in external relations. They also underlined that cultural cooperation with third countries has to be undertaken in line with the principles of the 2005 UNESCO Convention on the diversity of cultural expressions and that EU action in this area should be complementary to activities developed at bilateral level between Member States and third countries, demonstrating a real added value.

In relation to EU-China cultural relations, the Chair noted that <u>Ministers</u> were in general positive towards the specific recommendations suggested by the expert group.
