<u>The Council</u> held an exchange of views on the basis of the note submitted by the Presidency and questions contained therein.

The Council recognized that health sector makes an important contribution to economic growth and employment. <u>A number of delegations</u> called for better reflection of the role of good health of population in achieving the objectives of the EU 2020 strategy. It was stressed that the organisation and delivery of health services and medical care, which needs to be also respected in the European Semester process. The addition of specific headline target related to health was not supported and the best way forward could be the information and best practices exchange with the objectives to improve sustainability and efficiency of member states' health systems.
