## 4. Proposal for a Regulation of the European Parliament and of the Council amending Directive 2001/18/EC as regards the possibility for the Member States to restrict or prohibit the cultivation of GMOs in their territory [First reading]

<u>The Council</u> reached a Political Agreement on the basis of a Presidency compromise text drawn up after comprehensive discussions at technical level. <u>Most of Member States</u> (including some opponents to compromise texts which were previously presented) welcomed the release of the deadlock on this file which has been in place since 2011. <u>The Luxembourg</u> - which presented a statement as set out in Annex - <u>and Belgium delegations</u> abstained.

<u>The Italian delegation</u> announced its intention to reach an agreement with the EP during its Presidency.

#### Statement by Luxembourg

"The Luxembourg delegation wishes to thank the Hellenic Presidency for relaunching the negotiations on amending Directive 2001/18/EC allowing Member States to restrict or prohibit the cultivation of GMOs in their territory.

Our government recognises that the proposed amendments are aimed at improving the above-mentioned Directive. It particularly appreciates the fact that a new recital has been introduced which refers to the Commission's recommendations of 13 July 2013 on the development by the Member States of coexistence measures, including in border areas. Luxembourg particularly welcomes the fact that the grounds for prohibiting cultivation appear in the body of the proposed text and that the Member States may invoke reasons of public policy as such grounds. It also welcomes the strengthening of the EFSA risk assessment guidance.

However, our government is concerned about the involvement of GMO businesses in the proposed authorisation process. It wonders about the balance of power between the Member States, particularly those with smaller administrations, and GMO businesses. Our government also wonders whether the proposal might not lead to a spate of authorisations for GMO cultivation.

A large majority of the population in the Grand Duchy is opposed to the cultivation of GMOs. Moreover, the current government programme stipulates that Luxembourg will continue to apply the precautionary principle in respect of GMOs, promote sustainable "GMO-free" agriculture and defend its anti-GMO position both domestically and at EU and international level.

The Luxembourg government wishes to draw attention, in this context, to the Commission communication of 2 February 2000 [COM(2000)1] on the precautionary principle; the latter is also mentioned in Article 191 TFEU, which aims to ensure a high level of environmental protection. The current state of research does not allow us to rule out entirely the possibility of long-term risks associated with the cultivation of GMOs, including repercussions for fauna and flora and for public health, particularly since no long-term studies exist on this subject.

For these reasons, the Luxembourg government is unable to give its full support to the compromise proposal and must therefore abstain from the vote."

<u>The Council</u> held a policy debate on two legislative proposals (directives on medium-size combustion plants and on national emission ceilings) which are part of the Clean Air Programme for Europe.

The debate focussed on the main political issues, in particular on matters related to the scope such as flexibility and exemptions (10112/14), on the basis of questions prepared by the Presidency.

As regards medium size combustion plants, there was widespread support for the proposal which will be crucial to achieve compliance with air quality standards. However, <u>several delegations</u> requested additional flexibilities for specific situations and expressed concerns for small combustion plants and the emission limit values proposed.

With regard to national emission ceilings, many delegations supported the step-by-step approach and the coverage of all economic sectors, but concerns were expressed on the level of ambition, particularly as regards the ceilings to be reached by 2030. <u>A large number of delegations</u> said that further examination of the impacts of the proposed emission ceilings should be carried out, especially impacts on the agricultural sector. <u>The Commission</u>, in its final remarks, recalled the air quality objectives of the 7th EAP (Environmental Action Programme) and encouraged delegations to preserve the high level of ambition of these legislative proposals.

<u>The Council</u> held a public policy debate on the Commission communication on a 2030 framework for climate and energy policy. To structure the debate, <u>the Hellenic</u> <u>Presidency</u> had prepared two questions for the Ministers, as set out in doc. 10180/14. Following a full table-round, <u>the President of the Council</u> thanked the Ministers and the Commissioner for the exchange of views and announced that he would report on the outcome of the ministerial discussions in a letter to the President of the European Council with a view to contributing to the discussions at the European Council meeting on 26/27 June 2014, as well as to the overall process towards a final decision by the European Council in October.
