NB: Waivers based on the proportionality principle cannot be subdelegated.				

NB: The act of delegating and/or subdelegating is a right, not an obligation. Regarding delegations, Article 4(2) of the Internal Rules stipulates that 'the Commission itself may nevertheless exercise the powers it has delegated, either on its own initiative or at the request of the authorising officer by delegation.' Furthermore, Article 7(8) states expressly that 'An authorising officer [...] who has subdelegated his powers may, at any moment and without amending the instrument of subdelegation, himself continue to exercise these subdelegated powers on his own initiative or at the request of the person to whom those powers have been subdelegated.'
