The Council agreed on a general approach, as set out in 16054/14, and mandated the Presidency to enter into negotiations with the European Parliament with a view to an agreement at first reading. BE, BG, CZ, EE, IE, MT, NL and SK indicated they could not support the text of the general approach. LUX and NL made statements as set out hereafter.

### **Statement by Luxembourg**

"Luxembourg welcomes the significant progress made under the Italian Presidency, but wishes to point out that various points need to be considered in greater detail during proceedings under the forthcoming presidencies. Especially with regard to the provisions relating to insolvency protection for assisted travel arrangements, the implementation and supervision of such protection still raises a number of questions for the authorities responsible for transposing the Directive. Serious fears are also being expressed by members of the profession, who are mobilising against the relevant provisions.

The need to ensure legal certainty, the protection of travellers and healthy competition calls for clear, precise and easily applicable rules, in accordance with the requirements of "better regulation": a disproportionate regulatory burden should not be imposed on operators.

Furthermore, a balanced solution should be found for non-cancellable packages offered at more favourable rates; the current proposal would not in fact allow members of the profession to continue proposing such offers. More generally, the Directive should not lead to the disappearance of business models which have added value for travellers and companies.

Luxembourg remains confident that it will be possible to make the necessary adjustments as proceedings continue."

## **Statement by the Netherlands**

"The Netherlands would like to thank the Italian presidency and preceding presidencies for all the effort put into the process of revising the Directive on package travel and assisted travel arrangements.

The old package travel directive is in need of revision, due to the rather dramatic changes on the travel market.

The Netherlands supports the intended improvement of the protection of the consumer. However, the Netherlands feels that the current version of the proposal merits further efforts to both clarify the definitions (most importantly the definition of ATA) as well as elaborate further on the insolvency articles regarding ATA's with a view to optimize value added for both the consumer and traders and at the same time eliminate ambiguity that will cause problems in implementation. Furthermore, we stress the importance to avoid, where possible, unnecessary administrative burdens.

We therefore call upon the incoming Presidency and the Commission to take these concerns into consideration when negotiating with the European Parliament on a final text. Though we are sympathetic towards the objective of the revision of the directive, we cannot agree with the current proposal."

The Council adopted a general approach as set out in doc. 15735/1/14 REV 1 and mandated the Presidency to enter into negotiations with the European Parliament with a view to reaching an agreement at first reading. UK opposed the general approach and made a statement as set out hereafter.

**Statement by the United Kingdom**

"The UK opposes the adoption of the proposal for a Regulation on Personal Protective Equipment. While we support the Commission in its aim to simplify existing single market measures, and the work done to ensure that it follows the precedents established by the negotiation of the New Legislative Framework (NLF) package, we are concerned about the proposed extension of scope to include domestic dishwashing and oven gloves. The Commission's Impact Assessment fails to provide data to justify the change or to explain the scale of the problem, and at the same time states that costs for small businesses will increase by 10 – 20%. This will place additional obligations, which we believe are too prescriptive and disproportionate to the risks, on the manufacturers and retailers of these products. It could also be reflected in the prices consumers have to pay for these essential and regularly purchased household goods. We therefore are not convinced of the need to bring domestic dishwashing and oven gloves in to the scope of the Regulation."
