THE ASSOCIATION COMMITTEE IN TRADE CONFIGURATION,

Having regard to the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part, signed in Brussels on 27 June 2014, and in particular Article 404(1) thereof,

Whereas:

- (1) In accordance with Article 464 of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part ('the Agreement'), parts of the Agreement, including the provision on the establishment of the list of arbitrators, are applied provisionally as of 1 September 2014.
- (2) In accordance with Article 404(1) of the Agreement, the Association Committee in Trade configuration, as set out in Article 438(4) of the Agreement, is to establish a list of 15 individuals to serve as arbitrators,

HAS ADOPTED THIS DECISION:

Article 1

The lists of individuals who may serve as arbitrators for the purposes of Article 404(1) of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part, are set out in the Annex to this Decision.

Article 2

This Decision shall enter into force on the day of its adoption.
