FIGURE 3 – EVOLUTION OF FLAX AREAS 1970 – 2006 (source: AND International)




FIGURE 4 – EVOLUTION OF HEMP AREAS 1970 – 2006 (source: AND International)




FIGURE 5 – EVOLUTION OF PRODUCTION OF FLAX STRAW 1970 – 2006 (source: AND International)




FIGURE 6 – EVOLUTION OF PRODUCTION OF HEMP STRAW 1970 – 2006 (source: AND International)




FIGURE 7 – EVOLUTION OF PRICES 1995 – 2005 (source: AND International)




FIGURE 8 - VALUE OF ONE HECTARE OF FLAX BASE ON ESTIMATED PRICES (source: AND International on the basis of French data)




FIGURE 9 - VALUE OF ONE HECTARE OF HEMP BASED ON ESTIMATED PRICES (source: AND International and Nova Institute on the basis of German data)




FIGURE 10 – ASSESSMENT OF THE ADMINISTRATIVE COST OF PROCESSING AID FOR FLAX AND HEMP FIBRES
